Essential Duties & Responsibilities:

- Support the Departmental directive to operate the safest possible high-speed ferry service. Assist the Master with the management and safe operation of the vessel in a fashion that exceeds the highest standards within the passenger vessel industry. Always consider guest and team member safety a prime responsibility.
- Assist Master in navigation and control of the vessel. Manage and operate
 vessels within legal requirements of USCG, FCC, IMO-HSC, and other pertinent
 regulatory agencies. Compile, review and maintain official vessel logs and
 other necessary reports and forms. Take a lead role in maintaining and
 updating charts and publications.
- Assist Master in the role as onboard Risk Manager. Monitor safety issues on the vessel and correct problems under the direction of the Master. Assist Master in the establishment of a safety "culture" and take corrective action as situations may require. Schedule and perform Safety audits as mandated by company policy and as circumstances require.
- Take a lead role in the training of crew members. Participate and recommend actions regarding interviewing, training, and evaluation of Deck Crew candidates. Ensure that the performance and behavior of Deck Team Members meet legal and professional requirements. Recommend discipline for infractions of policy by Deck Department Team Members.
- Supervise embarkation and disembarkation of passengers and cargo.
- Organize and participate in drills with crewmembers as directed by the Master. Assure the proper recording of all drill activities.
- Participate in the development of task prioritization and capital projects in consultation with Master. Participate in Marine Department meetings as required by Master or Operations Manager. Follow the onboard chain of command structure and duties assigned.

- The majority of work is performed in a Marine environment in both indoor and outdoor conditions with exposure to various temperatures and weather conditions, along with moderate to loud noise levels.
- The Marine operation is subject to varying levels of motion, movement, and vibration.
- Additional job duties as assigned.
